Public Comments / Staff Update

- Kwame James Public
 - Has drafted a policy for flagpole use at the church and will distribute
 - Draft is presented as bylaw addendum but could be extracted as a separate policy
 - Clarifies that the flagpole is dedicated to GSA causes
 - Has clause for other uses pending board vote
 - Board agrees that this is more fitting as a policy vs bylaw addition
 - Policy Text
 - Harbor UU Gay Straight Alliance Flagpole
 - 1. Whereas the Harbor UU Gay Straight Alliance saw fit to raise funds and erect a flagpole located at the building's main entrance, on the corner of Montgomery Av. and McGraft Av., to recognize and celebrate LGBTQIA+ individuals, communities, and their causes,
 - 2. and whereas, Harbor Unitarian Universalist Congregation is, and intends to remain, a Welcoming Congregation, in accordance with the guidelines set forth by The UUA.
 - 3. the board shall ensure that the flag flown is of a type befitting the purpose for which the pole was first erected, examples being the Rainbow Pride Flag, the Progressive Pride Flag, the Transgender Pride Flag, or other similar flags,
 - 4. except by advance written request to the board, and subject to its approval by majority vote for the specified purpose and time frame requested.
